All requests for an exhibitor space must be held with a credit card to ensure the space is held. Full payment is required for all vendors within 2 weeks. Booth locations will be determined after receipt of completed application and full payment.

Spaces are first come, first serve.

Cancellations: 2 weeks prior to event incurs a 50% cancellation fee. 1 week prior to event incurs a 75% cancellation fee.

It is agreed that the event host KOZ Events or any affiliated companies or individuals are not liable for any injuries, or responsible for any lost, stolen or damaged items.

It is the vendor's responsibility to acquire all sales and health permits related to their participation in this event and to follow all respective permit rules and regulations. <u>Temporary event vendor application</u>
